2. The signed Absentee Bid Sheet, signed Terms and Conditions and check need to be returned by Noon on Thursday, August 21.
3. All items on this form must be completed.
4. To place an absentee bid, you authorize the auctioneer to bid on your behalf up to the limit of your maximum bid. A successful bid constitutes your agreement to purchase that item.
5. Contact us if you need an additional bid sheet.
6. The item will be purchased at the lowest possible price at or below your maximum bid.
7. If you intend only to win only one bid, you must check the box stating *"I will bid on this egg only if I am unsuccessful on my bids shown above"*.
8. You must provide your name, address and phone number along with the egg name and artist(s) name(s), starting bid(s) and maximum bid(s).
